- Practise saying some Māori place names together, focusing on correct pronunciation. Test each other.

- Research a whakatauki (Maori proverb) that you as a family connect with. Learn it together.
- Learn the sign of the cross in Māori or a simple prayer.

Simple Prayer Nau mai haere mai e hehu Karati ko koe te rawhiti o te ao – Welcome Jesus you are the light of the world.

Cross Country

We have been informed that the New Plymouth Cross Country has been cancelled this year. We are still awaiting the Taranaki Cross Country decision. As a result of this, we have decided to change the format of our school cross country for this year. We will be holding our 'in school' event on Friday 24th September. The Year 5 and 6 students have been involved in designing a cross country track in our own school grounds where they will still run the same distance has in previous years, but there will be some added fun obstacles. For those Middle and Senior competitive school runners, they will run the required distance to find placings in the event that the Taranaki Cross Country goes ahead. Children are asked to come to school on Friday 24th September in their PE uniform. At this stage under Alert Level 2 restrictions, we are not permitted to have any extra adults or parents onsite for this event.

Teachers have been busy writing reports during the lockdown time and are currently completing assessments needed for reporting.
